***Late-Payment Fees:** All payments for child care are due in advance of care given. Tuition for the new week is due on Monday morning, with a grace period until 6:00pm on Tuesday. A \$15.00 Late-Payment Fee will automatically be added to account balances every week that balances remain outstanding after that time. Children’s Center, as a non-profit ministry, must receive tuition payments on time in order to function. If your child is absent on Monday and/or Tuesday, tuition is still due by Tuesday at 6:00pm unless Parkgate Children’s Center was also closed.

Drop-In Rate: Basic Rate.....\$35.00 per day / Schoolagers (school-year after-school care only)...\$20.00
 Drop-in care is available only for children with full paperwork completed and on file in the Children’s Center office. Parents must check in advance every time to see if there is room for their child to receive drop-in care on a particular day, since space cannot be reserved for a drop-in child. The daily drop-in tuition fee, with registration fee as applicable, must be paid before leaving the child for care. If a full registration fee has been paid for the year, an additional drop-in registration fee is not due for a drop-in child until the year is up. If no previous registration fee has already been paid for the year, a drop-in registration fee of \$15 will be due at the time of the first drop-in day of care. On the fourth, seventh, and tenth drop-in days, an additional \$15 registration fee will be due. After the tenth drop-in day, the full \$60 in registration fees has been paid and no additional registration fees will be due until the anniversary of the first day of drop-in care for the most recent enrollment year. Multiple-child discounts do not apply for Drop-in care.

Tuition Rates include breakfast, lunch, and two snacks if a child is present during serving times. Serving times vary by class. Toddlers and Twos classes will be offered an additional late afternoon snack.

Multiple child discounts are available. For two or more siblings from the same household who are enrolled in the Center on a daily basis, there is a 10% discount off the tuition rate for the child (or children) with the lowest regular tuition rates. There is no multiple-child discount for drop-in students or registration fees.

Registration Fees.....\$60.00 per year
 Registration Fees are non-refundable. Registration Fees are due once each year, or more often if a child is withdrawn and re-enrolled at a later date within the same year. Multiple-child discounts do not apply for Registration Fees.

Tuition and Registration payments may be made by cash, check, or money order. There will be a \$25.00 charge automatically added to a child’s account for any check returned from the bank. After two returned checks, only cash payments will be accepted for a six-month period.

Late Pick-Up Fees: Children who are not picked up by the Center’s closing at 6:00 pm will accrue late pick-up fees to be added to the child’s account balance. There will be a \$1 per minute per child charge, based on the clock in the child’s classroom.

Additional Fees: Occasional additional fees may be necessary during the year for special testing, field trips, or other special activities that are offered. Parents will be informed of this in advance.
